

We will be leaving WGSS at 4:45 pm on the first Wednesday of the month. Ms. Bryant-Taneda and perhaps other teachers will drive participating students to the Langley Vineyard Friendship Church. It will be helpful if we have one or two more drivers depending on how many students go to each (monthly) visit. Transportation will **NOT** be provided back to WGSS, so students need to have a ride back with a parent or another adult. For safety reasons, students will not be allowed to take public transportation home. Also when students leave, they must check with Ms. Bryant-Taneda so we can ensure students and parents leave together.

The evening ends between 7:00 and 7:15 pm. We are asking parents to pick up their child at the Langley Vineyard Friendship Church (back entrance). The Church is located at 5708 Glover Road. The easiest approach is to take 208th to Logan Ave; then turn left on to Logan Ave, and go through the lights as you turn left and look for the first laneway (about 50 m, across from the back of Value Village). The entrance to the Vineyard is in the laneway. The phone number for Langley Vineyard Friendship Centre is (604) 530-8463.

Parents who are able to drive students to the Langley Vineyard are asked to fill out the *Parent Driver* Permission form. The permission form at the back of this sheet is for all trips (once a month). There will be no individual forms for each trip.

Students: Please sign your name on the sign-up sheet by Tuesday after school, the day before we go to Vineyard. There will be only 15 spots available each month.
